At the ISCB Utrecht conference (2015) the SiRA SC decided to commence the Wikipedia Initiative for statistics in regulatory affairs guidance for the Pharmaceutical and Medical Devices Industry. In 2016 the SiRA SC presented a poster at the ISCB Conference about the Wikipedia Initiative, dealing mostly with the generalities of Wikipedia, its use for statistics in the regulatory environment and how users could contribute to the Wikipedia Initiative[1].

1. OBJECTIVES



The main objective of the SiRA SC was to **initiate a comprehensive source of references** for statistical regulatory affairs guidance documents and related articles in **Wikipedia**[1].

The secondary objective was to **create a related Wikipedia User Guide**.

2. WIKIPEDIA ARTICLE

An **Outline for the Wikipedia Article** was prepared by the SiRA SC in Word format and agreed upon (see “Wikipedia Article: Table of Contents” in the side-panel).

In addition, the **SC members agreed upon the Leading Text and History** (§1) of the Wikipedia Article. The writing of these two sections and some other sections in Wikipedia was initiated by one member (HCB) in January-2017[2].

The article was assigned the category **“Biostatistics”**, classified under **“Statistics”**, comprising various relevant topics (e.g. Medical Statistics, Clinical Trials and Epidemiology).

3. WIKIPEDIA LIST

A SiRA SC member (JVT) initiated a **Wikipedia “List” of guidance documents** in July-2016[3].

A brief description and references to thirty relevant regulatory guidelines/guidances have been entered in the Wikipedia List by the SiRA SC members to date.



4. WIKIPEDIA USER GUIDE FOR SiRA GUIDANCES

Basic edits for Wikipedia were presented in the above-mentioned poster[1].

A **more detailed User Guide for editing/reviewing** the content in Wikipedia has been produced to aid potential volunteers to contribute to the **SiRA Wikipedia Article and List**[4].

5. DISSEMINATION OF THE WIKIPEDIA INITIATIVE

The SiRA Article and the List **have already undergone Wikipedia's internal review process** and were "accepted". Hence, they are both open to contributions from volunteers.

Formal dissemination of the material from the Wikipedia Initiative to the ISCB members and the wider statistical community is planned when a Viewpoint paper, which was submitted to the journal, *Pharmaceutical Statistics* (12 June 2017), has been published. A **six-month free open-access to the Viewpoint paper** has been negotiated by the SiRA SC with Wiley publisher.

Relevant information about the Initiative will then be uploaded on the ISCB SiRA SC page for access to the ISCB and non-ISCB members.

6. HOW DO I CONTRIBUTE?

Wikipedia is a **free-access and free-content internet encyclopedia** for reading, writing and editing. You are encouraged to participate in the development of the SiRA Wikipedia Article and List.

Download the SiRA Wikipedia User Guide^[4] and follow the instructions to create a Wikipedia login account.

Thereafter, **follow the instructions for editing** the existing sections or writing new ones, according to the "Wikipedia Article: Table of Contents" shown in the side-panel.
